CREDIT AGREEMENT – PLEASE READ AND SIGN BELOW

1. **TERMS OF SALE:** Unless otherwise agreed, Rhoads Energy accounts will be invoiced twice a month (through the 15th and last day of the month). Each invoice is DUE and payment must be RECEIVED within 10 days of invoice date. Billing frequency may vary by invoice, product, amount or billing division. Acceptance of payment(s) for past due amounts shall not affect the terms of this agreement. **ANY SPECIAL BILLING CONSIDERATIONS MUST BE AGREED UPON IN WRITING BY RHOADS ENERGY.**
2. Fuel prices are subject to change at any time without notice. Fuel purchased from the cardlock system shall include applicable state fuel taxes unless exempt from tax pursuant to Pennsylvania Use Fuel Tax. Exemption from state taxes shall be granted only upon proof of exemption as required by Rhoads Energy. Customer shall retain full responsibility for payment of taxes should a taxable use arise, including cancellation or expiration of exemption permits.
3. Past due balances are assessed a FINANCE CHARGE of 1.5 % per month (ANNUAL PERCENTAGE RATE 18%) or the maximum rate authorized by law whichever is lower; MINIMUM FINANCE CHARGE \$0.50. Pending credits from product returns, exchanges, repurchases or otherwise shall not be deemed payment unless and until such credits have been approved by Rhoads Energy and are reflected on customer's invoice or statement.
4. Accounts may be placed on hold or on a C.O.D./cash only basis at our option without advance notice. In no event shall Rhoads Energy be liable for any consequential damages or other loss which may result from the exercise of its option under this section 4.
5. In the event any account is not paid when due, the prevailing party shall be entitled to recover reasonable attorneys fees and any court costs, including costs of appeal or other review. In the event your account is placed for collection with a collection agency, you agree to pay any collection fee that may be assessed in addition to all other amounts owing. Parties hereby acknowledge making this agreement in the State of Pennsylvania and agree that jurisdiction and venue for any suit brought to enforce any term(s) of this agreement and/or any other action(s) arising from or as a result of this agreement shall be in Lancaster County, State of Pennsylvania.
6. Rhoads Energy shall be entitled to rely upon verbal order or signature by you or your apparent representative on any invoice for any sale or service performed, and such authorization is presumed to establish your acceptance of and agreement to comply with the terms and conditions set forth herein, without exception.
7. This agreement shall be subject to acceptance by Rhoads Energy. **Payment terms and payment method are ACH or check only. Payment by credit card not accepted. All new accounts are subject to credit approval.**
